

Call for nominations for election to the IUAES Executive Committee

The terms of office of the present IUAES Executive Committee come to an end directly after the end of the 18th IUAES World Congress in July 2018.

In accordance with the WAU Constitution and Operational Guidelines and Rules (OGRs) pertaining to the IUAES chamber, elections for a new IUAES Executive Committee (EC) must be held “over a 30-day voting period, commencing no less than 60 days and no more than 90 days prior to the first IUAES General Assembly meeting” to held at the 18th IUAES World Congress. Elections must be conducted electronically so that all signed and paid up IUAES members are able to vote.

Also in accordance with the Constitution and OGRs, it is the duty of the incumbent EC to re-elect, if deemed appropriate to ensure continuity, and for no more than one further term, one or both of the two Vice Presidents who were first elected at the time of the previous IUAES World Congress and who have served just one term.

As the Nominations Committee appointed by the EC, we are now calling for open nominations from among the individual members of the IUAES for the following positions on the EC:

- President
- Senior Vice President
- Secretary General
- Treasurer
- Up to four (4) Vice Presidents¹

All those nominated must be paid up individual members of the IUAES.

Each must be nominated by at least four paid up individual or group/corporate IUAES members. The nominators must be from four different countries.

Due to time constraints, nominations that do not conform to the rules will be disqualified without recourse, that is, they cannot be resubmitted with substitute nominators.

Each nomination must provide the name and address of the nominee who must sign that they accept nomination; and the names, addresses and countries of the four (or more) nominators.

Each nomination must indicate for what position the nominee is being nominated. It must also be accompanied by

- a strong rationale by the nominators for recommending the nominee;
- a brief (one page) cv/resume that highlights the nominee’s previous service to anthropology, to WAU (including the IUAES Commissions), or to other professional anthropology or ethnology organisations; and
- a one-page statement of intent detailing what the nominee plans to achieve for the IUAES during their term in office, if elected
- a signed nomination form, which includes a stated commitment by the nominee that they will work for the good of the IUAES and WAU.

Please note that a nominations committee has been established following due procedures. To ensure all vacancies are filled, the nomination committee will nominate candidates for the full slate. This does not, however, preclude further nominations from members and this call is for such nominations to be submitted. However, all nominees should be prepared to face a democratic contest.

¹ As indicated, for continuity, the EC may re-elect one or both of the Vice-Presidents elected for the first time during the immediately previous elections.
